1. Announcements And Committee Matters

- October meeting minutes accepted
- Adam Varat from Planning presented a project management update
 - Introduce new staff: Elizabeth Bender (Planning), Heath Maddox (MTA),
 Sarah Minnick (PUC)

2. Institutional Update: Interagency coordination and process

- David Alumbaugh, Peter Albert, Edgar Lopez presented on-going City efforts to improve street design and process;
 - o Reiterated departmental support for the Better Streets Plan
 - o Peter Albert described MTA Planning reorganization
- Committee members had the following comments and questions:
 - Will Dean Macris have a role in the Mayor's Office after leaving the Planning Department? *Yes*.
 - How can we get the Better Streets Plan to the top of the Mayor's priority list? Should CAC send a letter to the Mayor or meet with the Mayor or Board Members to describe institutional roadblocks?
 - What is meant by 'conflicting codes'? Have DPW staff seen document of code conflicts that was done early on in BSP process?
 - Need to think about how project scope has shifted. More policy and design guidance than institutional process. Need to consider spatial trade-offs from limited street space.

- o Describe role of City Design Group.
- Need to consider funding for bike, pedestrian, transit projects and develop a proposal with a dollar figure to take to the mayor. Need to focus on on-going pedestrian injuries when talking to decision-makers, who are crisis oriented. Show cost-effectiveness of Better Streets Plan recommendations by avoiding pedestrian injuries
- Should re-start working group to discuss how best to reach decisionmakers
- o Who facilitates interdepartmental working group? *Kris Opbroek.* How are topics put on the agenda? *Discussions among staff in the meetings.*
- Should ask for new ideas from interagency outreach, not just reactions to proposals.
- Need to be clear what Better Streets mantra is. Have seen disparate pieces but no coherent story about what we are trying to achieve.
- Look at a particular example of a street (e.g. San Bruno Ave.) when thinking about institutional roadblocks. Staff should come up with a list of policy conflicts.
- What do people think about a Director of Greening? Is it an important role we want to fill?

3. DRAFT Pedestrian Policies: Right Turn Movements and Crossings

- Cristina Olea presented information on right-turn movements and crosswalk markings
- Committee members had the following comments:
 - o Right turns on red (RTORs) need enforcement. Can be more dangerous where prohibited because pedestrians don't expect drivers to turn.
 - o Would like to see research on effectiveness of advance limit lines
 - o Show how prohibitions on RTORs effect Muni
 - Re: crossings, design guidelines should look at special paving (color, texture, etc.). Guidelines should emphasize visibility of crosswalk as a contrasting element, not just design.
