PROJECT DESCRIPTION:

The project proposed by the San Francisco Municipal Transportation Agency (SFMTA) is a pilot project to collect data on the effects of removing a lane along Folsom Street between 4th and 11th Streets in San Francisco's South of Market (SoMa) neighborhood. This section of Folsom Street includes four travel lanes and a bicycle lane in the eastbound direction. The pilot project would include removal of the right travel lane and reconfiguration of a bicycle lane buffered from traffic and parking, with right-turn pockets at certain intersections. Lane removal and bicycle lane reconfiguration would be performed using thermoplastic lane markings, with green paint at intersections to demarcate the bicycle lane and distinguish it from right-turn pockets. Small areas of the curb would be painted red around crosswalks at the intersections within the pilot project area to improve pedestrian safety. The project would be installed by the end of November 2013 and would remain in place for approximately 18 months, through May

2015. The thermoplastic lane markings and pavement/curb paint would be removed by grinding at the end of the pilot project period.
