**\*P3a. Description:** (Describe resource and its major elements. Include design, materials, condition, alterations, size, setting, and boundaries.)

This commercial building, located at the east side of Mission Street south of its intersection with 18th Street, covers almost all of a large corner lot measuring 65' on Mission Street and 147' on 18th Street. It is built to the lot lines, with no setback. The building is occupied by a discount outlet store.

This is a rectangular plan, single-story with mezzanine, flat roof, metal panel-clad building. The front elevation on Mission Street contains a wide squared vestibule, with double full-length sash wood doors, flanked by long bands of full-length display windows with metal frames, including some that are molded, indicating that they may be original. Above the entrance, a tall marquee tower projects from the mezzanine level, with a substantial flat rectangular base supporting step-up streamlined elements that culminate in a tall rounded, side-facing clock tower. The front and sides of the marquee tower display vertical bands of squared panels, with the front panels containing a stylized, circled "G" monogram, individual block letters that spell "GALIL". A flat horizontal strip divides the façade between the first floor and the mezzanine's long band of display windows. Above the mezzanine the façade consists of tall band of vertical metal panels below three raised horizontal bands that run across the roofline. The Mission Street front elevation and the 18th Street side elevation merge at the rounded corner. At the side elevation, the plate glass window bands at the pedestrian and mezzanine levels are continued, but are separated into bays by flat metal mullions. The lower window bays are boarded, as are two of the mezzanine windows at the rounded corner. Partway back on the side elevation is found a boarded side entrance and hood with streamlined, vertical elements that match the marquee tower. The horizontally banding continues around to the side elevation.

This building displays Art Deco architectural style, as indicated by the streamlined vertical tower marquee, horizontal banding, and metal cladding.
