## General Advertising Sign Program Team Recognized for Eliminating 700 Illegal Billboards

Earlier this month, the department's General Advertising Sign Program (GASP) team was recognized by Scenic America and SF Beautiful for their work on eliminating 700 illegal and non-conforming billboards from the City's streetscapes.

The team helped build and maintain an inventory of all general advertising signs in San Francisco, correct advertising signs that violate the Planning Code, and remove unlawful signs.

The Planning Department would like to thank Dan and the GASP team for their hard work in protecting the beauty and unique character of San Francisco.

### **New Bicycle Parking Requirements Approved by Planning Commission**

The San Francisco Planning Commission approved a legislative proposal to amend the current bicycle parking requirements in the Planning Code, in response to increased bike use in the city. The proposal categorizes the bicycle parking requirements into two types:

- 1. long-term parking geared towards residents and employees of buildings; and
- 2. short-term parking serving commercial building visitors.

In addition, requirements for required bike parking will vary depending on the building use, and the building's volume of bicycle trips. The proposal is anticipated to go before the Board of Supervisors in June 2013.

#### **Central Corridor Draft Plan Workshop**

The Planning Department will be hosting a series of monthly roundtables on key topics in the Draft Plan. These collaborative, informal sessions will be focused on specific policy or design matters related to the Draft Plan, and will help us refine the Plan, especially its zoning controls and design guidelines, for adoption in late 2014.

This session will not dive into a specific topic, but will be used as a brainstorming session to develop a list of topics that you would like to focus on for one or more of these future sessions. We want to make sure we know what you want to discuss, and which issues are your priorities. Based on conversations to date, a partial preliminary list of these topics include:

- Specific use controls (e.g. hotels, formula retail)
- Lot consolidation
- Incentives for retention of non-historic buildings
- Floor Area Ratio/Transferrable Development Rights
- Setbacks, building bulk controls
- Key development site design guidelines
- Open space design
