PROJECT UPDATES:

PERMIT AND PROJECT TRACKING SYSTEM (PPTS)



The Permit and Project Tracking System was expected to be ready by Fall 2013, but during the past few months, both Department of Building Inspection (DBI) and Planning identified the need for additional features.

System testing will start in November and run through January, with staff training expected to occur in January and February. The system is now scheduled to launch March 2014. Department staff will continue to work closely with DBI and the Accela/21Tech consultant team on the development of a new Permit and Project Tracking System.

Both departments will also conduct outreach to the public and city departments during the testing phase.
