#### Quarterly Report: July 18, 2012

The fourth quarterly report for fiscal year 2011/2012 includes hours and tasks undertaken by Planning Department (Department) staff in support of projects included on the Historic Preservation Commission's (HPC) current Landmark Designation Work Program. In addition to the total number of hours expended per project to date (July 1, 2010 to July 10, 2012), the report also documents the hours expended from July 1, 2011 to July 10, 2012 of fiscal year 2011/2012.

These reported hours do not reflect staff activities undertaken at the request of the HPC in response to community-initiated Landmark designation requests for the Gold Dust Lounge, Eagle Tavern, Guadalupe Church, and Women's Building murals.

In March 2012, the Department modified its contract with Preserve America. The modified grant deliverables are detailed under the Preserve America section below.
